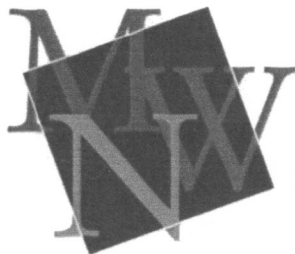

January 31, 2022

1. Basis of accounting

The basis of accounting applied in the preparation of the statement of financial position of Qualicum Beach Streamkeepers Society as at January 31, 2022, and the statement of operations for the year then ended, is the historical cost basis and reflects cash transactions

- (i) accounts receivable
- (ii) property, plant and equipment amortized
- (iii) accounts payable and accrued liabilities
- (iv) deferred contributions for unspent contributions

2. Purpose of the Organization

Qualicum Beach Streamkeepers Society's purpose is to protect and restore local aquatic habitats by assessing the health of local streams and wetlands and by helping to design and undertake their restoration projects, to educate the public on the importance of watershed resources, to encourage communication and co-operation in watershed management, and to provide long-term monitoring of these aquatic habitats.
