Items of Business

- 1. <u>Opening Remarks</u> President David James called the meeting to order at 10:00am, and outlined the agenda for the meeting.

- 4. <u>Guest Speaker</u> David introduced Guest Speaker, Dr. Brian Riddell, President and CEO of the Pacific Salmon Foundation. He gave a wide-ranging presentation of the State of Salmon. He believes the fundamentals of salmon are basically good. The problems we are seeing now have a lot to do with not doing much over the past 15-20 years. He sees salmon as a metric for the health of the BC environment. He was very interested in the recruitment of volunteers, and new ideas to engage more people. He also wants feedback on a potential Fall 2017 Visions conference. Peter Drummond thanked Brian and presented him with a few tokens of our appreciation for his time including a yellow fish!
- 5. Financial Report Gord Almond, Vice-President presented the financial highlights from the Financial Statements prepared by McIntosh, Norton, Williams for the QBSS year ended January 31st, 2016.
- Revenue for the year was \$1913. with expenditures of \$5996., leaving net assets at the end of the year of \$11,197. It was moved by Peter seconded by Neil that the financial statements be accepted. Carried.
- 6. Minutes of the 2015 AGM which was held on March 14, at Deez Restaurant in Qualicum Beach were reviewed. Moved by Gord seconded by David that the minutes be accepted as drafted. Carried.
